FUND AIM

The objective of the Fund is to provide growth by tracking the capital performance of the FTSE 250 ex. Investment Trusts Index (the "Index"). This objective is after the deduction of charges and taxation.

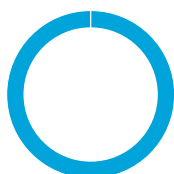
PORTFOLIO BREAKDOWN

INDEX FUND MANAGEMENT TEAM
